


Fig. 1: Assembly C6 X1-P1




Fig. 2: Connections C6 X1-P1




Fig. 3: Voltage supply C6 X1-P1




Fig. 4: Description of the LEDs C6 X1-P1




Fig. 5: Dimensions C6 X1-P1
